**The OverWatchUSA Local Hundred:** OverWatchUSA calls our local chapters, 'Hundreds', based on a plan laid down by Thomas Jefferson. The OverWatchUSA Hundred is the axis where the entire plan comes together.

In building these local hundreds, we aim to build Patriot Christian Communities, engaged at every level of their local community, and standing guard over Liberty. A united voice and vision for the local area, and a defense and response against tyranny.

### ***OverWatchUSA Statement of Faith***

- We believe in the Scriptures of the Old and New Testaments as verbally inspired by God and inerrant in the original writing, and that they are of supreme and final authority in faith and life.
- We believe in one God, eternally existing in three Persons: Father, Son and Holy Spirit.
- We believe that Jesus Christ was begotten of the Father, conceived by the Holy Spirit, born of the Virgin Mary, and is true God and true man.
- We believe that man was created in the image of God; that he sinned and thereby incurred not only physical death, but also spiritual death which is separation from God; and that all human beings are born with a sinful nature and are sinners in thought, word and deed.
- We believe that the Lord Jesus Christ died for our sins, according to the Scriptures, as a representative and substitutionary sacrifice; and that all who believe in him are justified on the ground of his shed blood.
- We believe in the resurrection of the crucified body of our Lord, in his ascension into heaven, and in his present life there for us, as High Priest and Advocate.
- We believe in the personal, visible, and imminent return of our Lord and Savior, Jesus Christ.
- We believe that all who receive by faith the Lord Jesus Christ are born again of the Holy Spirit, and thereby become children of God.
- We believe in the bodily resurrection of the just and the unjust, the everlasting blessedness of the saved and the everlasting punishment of the lost.

## **Terms of Agreement**

The **Local Hundred** agrees to the following:

- Adhere to the standards and Statement of Faith of OverWatchUSA (OUSA). All Leadership and officers of OUSA must agree with the Statement of Faith.
- Use OverWatchUSA materials and maintaining the organization of an OverWatchUSA Hundred.
- Form and maintain a OverWatchUSA Service Force (OSF) Defense Company and appoint a Captain to command it.
- Pledge to mutually support other OverWatchUSA Hundreds, by working together, providing a mutual defense, and support.
- Pledge to maintain the local OverWatchUSA Hundred's local focus and responsibilities.
- Use funds from OverWatchUSA responsibly and in a manner consistent within the vision of OUSA.
- Be Accountable to OverWatchUSA pertaining to funds
- Maintain communication between the Hundred and local OverWatchUSA Region.
- Oversee and maintain the quality of the Hundred, ensuring that it aligns with the overall vision of OUSA from the time of the Partnership Agreement.

**OverWatchUSA** agrees to the following:

- Respect the OverWatchUSA Hundred's sovereignty over local matters and not micromanage the local hundred. Selecting of local leadership and setting a local vision is the responsibility of the OUSA Local Hundred.
- Provide direction pertaining to Regional and Statewide goals and initiatives.
- Provide Support and Training for local Hundred Leadership.
- Provide a structure for the OverWatchUSA OSF Defense companies and provide higher levels of leadership for training, emergencies, and crisis.
- Help resolve leadership conflict.
- Maintain communication with the Local Hundred and keep them "in the loop".
- Provide up to date materials and curriculum.
- Be accountable to all the local Hundreds.
- Be financially accountable to OUSA Hundreds
- Provide a platform to foster ideas, voice concerns, etc. with the Hundreds Congress.
- Keep Christ as our center
